### Rural Arterial Program Actions


## UNMANNED AERIAL VEHICLE (UAV)

The prospect of using an UAV in public works is becoming more likely in the near future. A presentation on UAVs in road design at the recent Road Design Conference generated great interest among county design staff. Recognizing both that interest and the capabilities of this technology, along with the possibility of great savings, CRAB reached out to a company called SenseFly out of France and Switzerland that provides UAVs and software. Baptiste Tripard of SenseFly, hearing of the unique nature and innovation at CRAB and Washington counties, visited to demonstrate their products and propose the development of a cohesive strategy to make UAVs authorized in Washington counties (hopefully in one action). The demonstration was impressive, showing an incredible ease-of-use and very accurate same-day results at a very low cost compared to conventional survey methods. Mr. Tripard is now working in Washington D.C. with Congress, the FAA and others to push along the approval process for the authorization for public agencies to use UAVs.




The above photo shows the launch in Spokane of an eBee UAV supplied by SenseFly. The UAV flew an easily programmed grid, staying safely within an established boundary, and returned to its defined launch point with thousands of individual photos that were then stitched together into a topo for direct import into AutoDesk Civil3D. The challenge now is to get the FAA to grant our counties either a "Certificate of Authorization" for use or an "Exemption" from the current restrictions. Jim Ayres has scheduled an "Introduction to UAV" class on April 14<sup>th</sup> at CRAB, where a flight will be simulated and the software will be demonstrated. Sign up online at the CRAB website.
