
RURAL ATERIAL TRUST ACCOUNT (RATA) ACTIVITY AND BALANCE SUMMARY

County Engineer Desk Manual

For many years, CRAB has provided County Engineers and other county Public Works staff a variety of information resources. One of these information resources is the County Engineers' Desk Manual which contains guidance on a variety of technical and administrative issues affecting counties and county engineering functions. Following more than a year in development, a major revision was released in November 2010 and first amended in May 2011.

In addition to continued use as a hardcopy reference notebook, the design of the new Desk Manual takes advantage of current internet technology through the inclusion of over 1,500 internet "hotlinks" embedded within the document's text.

The most recent update to this Manual was released November 2011, and included:

- Amend Section 1.2.0 added links and material regarding public lands, population, and county roads
- Amend Section 2.1.1 added material regarding "road purpose"
- Amend Section 2.1.3 additional WAC references
- New Section 2.1.7 Risk Management
- Amend Section 3.1.2 amended property tax information

- Amend Section 8.3.0 added internet links to various training opportunities
- Amend Section 8.6.0 updated Desk Manual change record and listing of available supplemental information
- Correction of various broken or updates to internet "hotlinks"

The training is designed for, and most effective, when there is a mix of counties represented as well as a mix of County Engineer, Public Works Director, Assistant CE's and PWD's, and other senior PW staff specialists.

While this training has been provided by CRAB for many years, it is constantly revised to highlight current issues and challenges.

During December 6-8, an 18-hour training agenda was presented at the CRAB office.

It included 11 participants, representing 7 different counties. The agenda included:

- General information about counties, county roads, and county officials
- Summary of laws and rules affecting the Office of the County Engineer
- Introduction of and discussion about:
 - Management, accounting, and purchasing
 - o Taxes and other revenues
 - Planning and program development
 - Reporting requirements and audits
- Summary of other support services available through CRAB

While these 3-day sessions are very intense as to agenda content, there is significant amount of time built into the agenda to promote learning by applying the presented material through discussion of real-time issues and questions. The mix of counties and county staff specialties represented December 6-8 allowed for very lively discussion and debate on a variety of current matters of particular interest to the participants.

TECHNOLOGY UPDATES

Mobility – Transportation Asset Management

Further development and enhancements to Mobility continued this past quarter. On October 13th Mobility 3.1.0 was released which had several enhancements requested by Mobility users. It included a new comment field available in all inventories, sian retro-reflectivity techniques, a few new canned reports, some new custom report views for various inventories and a cloning feature for Many small ease-of-use maintenance. features were also included in 3.1.0.

On October 17th SignRate 2.0 was released that included a number of new features. Uploads and downloads between Mobility and SignRate are now simpler and faster now that these are done directly from SignRate using web-services. Location information is clarified while in the field with the addition of reference points and coordinates to the mobile application.

Good progress has been made in adding new inventories for Railroad Crossings, Short Span Bridges, Traffic Signals, Cattle Guards and Curb Ramps. Users of Mobility can expect these and other valuable enhancements to Mobility in the next release, expected in early 2012.

Design Engineering Program

The CRAB design engineer continues to provide excellent support and training to all of Washington's county road design staff. The challenge of having most counties changing to the AutoCAD Civil 3D software for their design efforts has been answered in various and creative ways. He has dedicated himself to becoming a necessary expert in Civil 3D as well as continuing to provide support for those who

continue to use the Eagle Point software. He gives introductory classes in Civil 3D on a regular basis here at the CRAB training facility. Each student attending one of these classes saves their county about \$1295. He currently brings in an outside expert for assistance in the advanced training but expects to take over that role later this year.


The annual Road Design Conference was a great success in October with attendees from twenty more than counties. Attendance was somewhat less than in the past due to our poor economy but is still very valuable to those willing to make the commitment. The event promotes highly valuable networking and collaboration among attending county design staff, vendors, consultants and other experts in the desian discipline. **Presentations** included the significant switch to AutoCAD Civil 3D by CalTrans for their road and highway projects, the I-5 Columbia Bridge replacement, the US Army Corp of Engineers vision in using Building Information Modeling, managing base map data, best practices in pavement preservation, and ADA requirements for sidewalks, curb ramps and crosswalks.

CRAB Website and Online Assistance

The CRAB technology team continues to take advantage of emerging technology and state-of-the-art methods in our efforts to assist counties. RAP Online was enhanced this last quarter and has been embraced by its users. The CRAB grant program manager is able to better manage the RAP Program. County RAP managers have a more flexible and access complete to their project information ease more in submitting, managing and tracking projects. CRAB IT has implemented two forums by which users of both Mobility and Design Software can easily interact with each other and with CRAB on troublesome issues or simply finding better and more efficient solutions. CRAB's network infrastructure uses state-ofthe-art technologies to assure a stable and secure computing environment for agency staff and for our customers. The utilization of latest technologies such as virtualization, clusterina. cloud computina. desktop and web services ensures a highly safe and high-performance environment. Downtime over a seven year period has been less than one percent. Various software and hardware devices prevent unwanted intrusions, viruses and SPAM from impeding efficiency. Email filters and appliances together stop about 97% of unwanted email. The privacy and confidentiality that these barriers provide is all the more important when you consider that well over 500 county personnel securely and safely access CRAB systems daily. Collision Locating Coding Form Submittals

The Standards of Good Practice require the counties to respond to at least 90% of the collisions compiled by the WSDOT Statewide Traffic and Collision Data Office (STCDO). As of December 31, 36 of 39 counties were at or above this performance measure. Three counties (Benton, Columbia, and Garfield) were at better than 83%, but were experiencing difficulties in accessing the WSDOT on-line data for 1 to 15 collision reports. Based on the data readily available from WSDOT, all 39 counties are in full compliance, with an overall compliance rate of 96.5%.
