2011 RECORD OF COUNTY COMPLIANCE

Standards of Good Practice Report Submittals, February 1, 2012

Road Levy: All 39 counties submitted the required forms by the established deadline.

Summary of State Auditor's Reports Findings

Staff reported that 7 county audit reports representing 7 counties had been reviewed since the January 2012 Board meeting. None revealed substantive findings involving county road funds. Staff Contact: Walt Olsen, Walt@crab.wa.gov, (360) 350-6080

Additional 3.5 Million Dollars for County Preservation Activities

The recent supplemental budget action by the legislature has provided an additional 3.5 million dollars to the County Arterial Preservation Program which will be transferred from the Traffic Safety Account and generated from certain fee increases payable to the Department of Licensing. The 3.5 million dollar figure, available in this biennium, is expected to increase in future biennia to approximately 10 million dollars.

CRAB expects to distribute this additional 3.5 million in the same manner and by the same formula under which current CAPA distributions are made to the counties for preservation work. CRAB staff will meet in mid-May with representatives from the Office of Financial Management to discuss the details of the transfer and distribution, and then present our distribution plan to the Joint Legislative Transportation Committee when it meets in conjunction with the AWC conference in Vancouver in June.

CRAB is very appreciative of the legislature's effort to direct additional resources to the pressing need of system preservation, and will distribute these additional dollars soon enough that they may be used in county preservation projects this summer.

Rural Arterial Program Issues Review

There was one project issue brought to the CRABoard in April 2012. Mason County, per their letter dated April 16, 2012, has requested a scope change for the RATA funded North Island Drive project. The request is to reduce the design speed for one horizontal curve from 40 mph to 35 mph (the exiting safe speed is 20 mph), and also to extend the project limits from 1.31 to 1.50, with no reduction in RATA funding.

Staff Analysis and Recommendation:

Revised Ranking:

Staff has reviewed the project site and finds the proposed design speed reduction lowers the project score from 76.19 to 74.94. With the proposed extension the score is further reduced to 73.41. Since the lowest ranked project receiving funding on the array scored 43.00, the North Island Drive project would still have been funded with the scope changes being proposed.


Remaining Improvements:

The county is committed to making the alignment, structural and all remaining geometric improvements to full design standards as reflected in the prospectus. The county plans to add warning signs before and after the reduced speed curve location and install centerline pavement markers the full length of the project.

Findings and Recommendation:

Staff finds the county is making best use of the RATA funding granted for the North Island Drive project with these revisions, and recommends approval of the reduced curve speed and extension of the project with no reduction in RATA funding.

RURAL ATERIAL TRUST ACCOUNT (RATA) ACTIVITY AND BALANCE SUMMARY


Circle Chart:

TECHNOLOGY UPDATES

Design Engineering Program

Over the past two years nearly all Washington counties have adopted AutoCAD Civil 3D as their primary road design software. While the CRAB design engineer, Jim Ayres, continues to support the previous CRAB-provided software Eagle Point and CEAL, he is now providing first rate training, support and consultation for Civil 3D. Contact Jim Ayres at the CRAB offices or our website for information on the free training offered at CRAB.

This spring Jim did much to improve Washington State's relationship with AutoDesk, the company that provides Civil 3D, a move which should prove beneficial to all state users of this design software. In April the west coast representative for AutoDesk brought a strong team of experts to both Olympia and Wenatchee for a free two day workshop on various technical design issues. Nearly 50 county staff attended in Olympia and 38 attended in Wenatchee. CRAB also invited a few **WSDOT** staff and local engineering knowing that consultants. establishina common ground amongst the community

of design professionals will benefit all involved. Topics presented included What is New in Civil 3D, Design Visualization, Buildina Information Modeling, Infrastructure Planning for Water Resources. AutoDesk has committed to a continuing positive relationship with Washington county users of Civil 3D, to include a large presence at CRAB's 23rd Road Design Conference in November and more free workshops.





Mobility – Transportation Asset Management

Mobility 3.2.0 is essentially complete and will be deployed after testing. This release, with the addition of five new inventories, brings the count to 26 road system inventories. The five new assets to be inventoried are Short Span Bridges, Traffic Signals, Railroad Crossings, Curb Ramps and Cattle Guards. A further enhancement in this release is the ability to more easily record GASB information. This new release will have other enhancements such as additional custom and canned reports and enhancements to the Collision Location and Analysis System (CLAS). CRAB is also working with the Transportation Data Office to improve overall performance to the CLAS.

STAFF ACTIVITIES

Rural Arterial Program (RAP) Site Visits

Thirty-seven of the thirty-nine counties submitted a total of 152 preliminary prospectuses for Rural Arterial Program (RAP) grants by the March 1, 2012 deadline. The estimated costs for the 152 projects total \$280,014,200, and potential RAP funding requested \$230,492,100. Four CRAB engineers met with county staff members and visited all 152 project sites in March and April in order to perform visual ratings and discuss the

scope of the potential projects. The pavement information will be shared with the counties in June. A fewer number of final project prospectuses will be due at the CRAB office September 1, 2012. The project selection process for the 2013-2015 biennium will be completed at the CRABoard Meeting in April, 2013, when approximately \$40 million in grants will be awarded.
