## CALL TO ORDER

Second Vice-Chair Woods called the meeting to order at 11:00 am.

## SECOND VICE-CHAIR'S REPORT

## Approve Agenda for the October 27-38, 2016 Meeting

Mr. Weber noted Commissioner Campbell's presence, and asked that an update on the Okanogan County road log issue be put on the agenda following Mr. Hart's reports. Commissioner Coffman moved and Commissioner French seconded to approve the agenda as amended. **Motion passed unanimously**.

## Approve Minutes of July 28-29, 2016 CRABoard Meeting

Mr. Storey moved and Commissioner Janicki seconded to approve the minutes of the July 28-29, 2016 CRABoard meeting as presented. **Motion passed unanimously.** 

## RURAL ARTERIAL PROGRAM

## Program Status Report

Mr. Hart reviewed the RAP status report. There are 91 projects currently being funded,

and 17 newly-approved projects with no RATA paid to date. CRAB has total anticipated revenue of \$562,386,379 through the 2015-17 biennium. \$527,421,397 has been expended to date. There are outstanding obligations of \$127,413,328.

## Resolution 2016-009 – Correction to Resolution 2016-008 - Apportion RATA Funds to Regions

Mr. Hart presented Resolution 2016-009 – Correction to Resolution 2016-008 -Apportion RATA Funds to Regions. Mr. Hart noted that Resolution 2016-008, approved by the CRABoard on July 28, 2016, listed the estimated amount for June 2016 and not the actual amount deposited. The corrected resolution approves that the revised amount of \$5,004,482 deposited to the RATA for April, May and June 2016 be apportioned to the regions by the established 2015-17 biennium regional percentages after setting aside \$121,125 for administration.

Mr. Storey moved and Commissioner Coffman seconded to approve Resolution 2016-009 – Correct Resolution 2016-008 - Apportion RATA Funds to Regions. **Motion carried unanimously.** 

## Resolution 2016-010 – Apportion RATA Funds to Regions

Mr. Hart presented Resolution 2016-010 – Apportion RATA Funds to Regions, which approves that the accrued amount of \$5,000,731 now credited to RATA for July, August and September 2016 be apportioned to the regions by the established 2015-17 biennium regional percentages after setting aside \$121,125 for administration.

Mr. Storey moved and Commissioner French seconded to approve Resolution 2016-010, Apportion RATA Funds to Regions. **Motion carried unanimously.** 

# Review 2017-19 Project Arrays

Mr. Hart presented the proposed priority array for the 2017-19 biennium. He noted that all counties except King, Pend Oreille, and Walla Walla, who have large and/or partially funded active projects, submitted proposals by March 1, 2016 through RAP Online. Staff reviewed 124 projects in the spring of 2016 and 54 final prospectuses were submitted, requesting a total of \$64,673,922. Thirty-four partially-funded projects were placed at the top of the new arrays showing funds gained in the previous biennium and funds yet to be allocated. A total of 88 projects are on the proposed array. He reported that the estimated revenue for the 2015-17 biennium is \$42 Million, which includes interest accrued and turned-back funds.

# Project Request Actions Taken by CRAB Staff

Mr. Hart reported that Clark County had requested an increase in RATA funding of \$117,975 for their Blair Road project to upgrade approach guardrail on Blair Zeek Bridge, which was below standards but was not included in the original prospectus; and to address a slide condition adjacent to the road that the county did not consider at the time of prospectus submittal. They also asked for a modification to the scope of work, removing their commitment to protect non-mailbox hazards from 19 to nine total. Also,

five utility poles they had committed to moving away from the roadway would remain in place and be protected by guardrail.

After field review, staff found the items for increase did not meet the "unforeseeable and extraordinary" criteria required for CRAB support of an increase in RATA funding.

In follow-up discussions with CRAB staff, the county decided to withdraw the request for additional funding but still propose the scope change. The items of the scope change were found to be minor and incidental to the original scope of work. After review of these issues with the CRAB Director, the scope change was approved and a contract amendment was offered.

# **OKANOGAN COUNTY ROAD LOG**

Mr. Weber introduced Commissioner Campbell, who brought a response to the letter sent by staff to the county regarding the need to reconcile their road log. Commissioner Campbell reported that substantial progress has been and that the county's ultimate goal is to have a county road log that accurately lists the roads they have a legitimate claim to. He noted that they have estimated 112 miles of roads that may potentially be added to the system and 87 miles that may be removed, so it will take some time before they have completed all the necessary steps to achieve their final objective. He reported that the county will be ready to submit those changes that have been properly completed to their road log by December 31, 2016.

# Second Vice-Chair Woods called the meeting back to order at 12:47 pm.

## DIRECTOR'S REPORT

## **Director's Activities**

Mr. Weber reported on his recent activities.

## 2017 Meeting Schedule

Mr. Weber presented possible dates for the 2017 CRABoard meeting schedule. Following discussion, Mr. Storey moved and Commissioner French seconded to set the 2017 CRABoard Meeting dates as January 26-27, April 27-28, and October 26-27 in Olympia; and August 10 in Wenatchee. **Motion passed unanimously.** 

# Approve Annual Certification Form

Mr. Weber noted the usual date changes. Mr. Olsen reported that all annual forms are being made electronic, and will be filled out and submitted online in the near future. Mr. Pohle noted that another form will be added in 2018 that will include the marine navigation and moorage reporting requirements.

Commissioner French moved and Commissioner Janicki seconded to approve the 2017

Annual Certification Form. Motion passed unanimously.

## Current Budget Status

Mr. Weber noted a few negative variances on individual line items, which will continue to decrease as we proceed through the biennium. The agency is in strong fiscal condition.

## 2017-19 Budget Submittal

Mr. Weber informed the Board that the 2017-19 budget request has been submitted to the Office of Financial Management. It generally maintains current budget levels with inflation factors. A request has been made for approximately \$40,000 in additional appropriations to help offset the costs of recent and future employee retirement buyouts. He noted that in the future, the agency's servers will be required to be moved to WaTech in their building and maintained by them. This will increase the agency's operating costs.

Second Vice-Chair Woods asked about the future of the Road Design Conference. Mr. Weber reported that the conference will continue, but the Road Design Association will be dissolved and some of the details will change, the major one being that there will be no registration fee and no meals will be provided with the conference. The net cost to the counties will differ very little. CRAB staff will continue to organize the conference and will encourage the participating vendors to host the various events.

## Second Vice-Chair Woods called for a brief recess.

## WORK SESSION

Mr. Weber presented a suggested timeline for the Executive Director recruitment. His last day will be September 1, 2017.

Ms. Pendleton noted that the Board will need to adopt a position description and set a date to go to advertisement at the January 2017 Board meeting. Mr. Weber suggested that the Board authorize the state personnel department to screen the applications and eliminate those that do not meet the minimum qualifications. Ms. Pendleton will demonstrate the online set-up of the position posting at a work session during the January 2017 Board meeting.

## County Road Administration Board Friday, October 28, 2016

## CALL TO ORDER

Second Vice-Chair Woods called the meeting to order at 8:32 am.

Ms. Pendleton presented an outline of topics for the work session on the Executive Director Recruitment planned for the January 2017 CRABoard meeting. The Board approved the content.

## DEPUTY DIRECTOR'S REPORT

### **County Engineers/Public Works Directors**

Mr. Olsen reported no changes since July 2016.

### **County Visits**

One official visit was made to Clark County since July 2016. Numerous contacts with County Engineers took place in other venues.

### State Auditor's Report

The 1997 State Auditor Office (SAO) audit of CRAB concluded that the minutes of the Board meetings needed specific mention of SAO audits of the counties and of any findings that might relate to the statutory responsibilities of CRAB. The minutes also need to reflect any recommendations from the CRABoard to staff in response to the audits. This report details staff procedures to satisfy the SAO.

CRAB has reviewed 53 audit reports representing 33 counties since the July 2016 Board Meeting. Twelve audits contained a total of 15 findings issued and 15 prior findings updated. One new finding and two previous findings involved County Road Funds in some form. Any audits with a number in the "Co. Rd?" column reveal substantive findings involving County Road Funds.

## **Deputy Director's Activities**

Mr. Olsen reported on his activities since the July 2016 meeting.

## STAFF REPORTS

## **Compliance and Data Analysis**

Mr. Pohle reported on two recent audit findings. Clark County did not have adequate internal controls to ensure compliance with federal grant requirements for allowable costs. The Public Works staff had insufficient knowledge and training of federal requirements for allowable costs to ensure compliance, and monitoring by management was not adequate to detect an issue. Although the SAO disagreed with the county's methodology, the amounts charged to the grants was reasonable, so the costs were not questioned.

In Skamania County, CRAB staff has been monitoring a continuing Finding which effects the Road Fund. For at least four consecutive audits, the SAO has issued a Finding that the county's financial condition continues to decline and is at risk of not being able to meet its current obligations and maintain services. SAO reports this issue only partially resolved per the 2015 audit. CRAB staff continues to support county Public Works staff on a consultative basis.

Mr. Pohle briefed the Board on staff's recommended changes to Chapter 136-12 WAC – Vacancy in Position of County Engineer, most of which add the words "or change" as well as "vacancy" to the reporting requirements; and Chapter 136-18 WAC – Construction by County Forces, which removes a special reporting section, 136-18-070, that is no longer necessary. The Board will be asked to vote on whether to move forward with these changes at the January 2017 CRABoard meeting.

Mr. Pohle reported on his recent activities.

## Intergovernmental Policy Management

Mr. Monsen reported on his recent activities.

He noted that County Engineers' Training is scheduled for December 6-8 in the CRAB offices, with fourteen participants are registered from nine counties. Customized training is scheduled for November 8-9 in Lincoln County, with 12 participants from four counties.

He noted challenges and changes to various year-end financial reporting requirements to the SAO and WSDOT. Solutions likely to be implemented as a part of year-end 2016 financial reporting were reached between CRAB and those agencies which will improve CRAB staff's extraction of data from the WSDOT reports. As a part of sending year-end actuals to the SAO, counties will be required to submit additional details in order for "transportation" data to be extracted for WSDOT purposes, and to ensure all Road Fund details are available for CRAB purposes.

Mr. Monsen reported that the latest update to the County Engineers' and Public Works Directors' Desk Manual was released in late September. He gave a brief presentation on the format, content, and recommended use of the manual. He noted that all hyperlinks in the electronic version are checked annually for accuracy.

# **CRABoard By-Laws**

## ARTICLE I PURPOSE

The County Road Administration Board shall be conducted in accordance with the provisions of RCW 36.78 and shall perform the duties and functions as therein prescribed.

## ARTICLE II MEETINGS

<u>Section 1. Place of Meetings.</u> Any and all meetings of the Board shall be held in the state of Washington.

<u>Section 2. Time of Meetings.</u> The regular meetings of the Board shall be held quarterly at a time and place designated by the chairman; provided that, the chairman may call additional, special meetings at a time and place to be designated; provided further, that written notice be sent to each member and filed with the code revisers office.

<u>Section 3.</u> Order of Business. The order of business at the Board meetings shall be as follows:

- (a) Call to Order
- (b) Minutes of the proceeding meeting
- (c) Report of the Chairman
- (d) Report of the Director
- (e) Rural Arterial Program Report
- (f) Public Hearing (if needed)
- (g) Budget Report
- (h) Other Division Reports
- (i) Work Session (if needed)
- (j) Adjournment

Provided, that in the absence of objection, the Chairman may vary the order of business.

## ARTICLE III QUORUM

A majority of five (5) members of the Board shall constitute a quorum.

<u>Section 1.</u> Each member of the Board shall be entitled to one vote and no proxies are allowed, and a majority vote is all that is required to decide any question.

## ARTICLE IV OFFICERS

<u>Section 1. Chairman.</u> The Chairman shall be selected from the members of the Board and shall be elected at the meeting of the Board in July of each year. The Chairman shall hold office for a term of one year, provided that a Chairman may be re-elected for successive terms. The Chairman shall preside over all meetings and perform the general powers and duties of a Chairman, including the appointment of subcommittees.

<u>Section 2. Vice-Chairman and Second Vice-Chairman.</u> A Vice-Chairman and a Second Vice-Chairman shall be chosen from the members of the Board at the time of selection of Chairman, and shall have the same term of office.

The Vice-Chairman shall perform the duties and exercise the functions of Chairman during the absence of the Chairman.

The Second Vice-Chairman shall perform the duties and exercise the functions of Vice-Chairman in the absence of the Vice-Chairman.

<u>Section 3. County Road Administration Board Executive Director.</u> The Board shall appoint an Executive Director pursuant to the provisions of RCW 36.78.060 who shall be chief administrative officer of the Board and shall be responsible for carrying out the policies adopted by the Board.

<u>Section 4.</u> Staff. The Executive Director shall employ such staff as may be approved by the Board and funded by the Legislature.

## ARTICLE V OFFICE

<u>Section 1. Location.</u> The Board shall select the location of the office of the Director, which shall also be the general office of the County Road Administration Board.

<u>Section 2. Procedures.</u> From time to time the Executive Director shall develop and effectively administer procedures governing the duties of the staff and the internal operations of the County Road Administration Board.

Change: April 2005 – second vice chair added

## ARTICLE VI INSTRUMENTS

<u>Section 1.</u> All vouchers, drafts, orders and payrolls for payment of salaries and expenses shall be signed in the name of the County Road Administration Board. The Executive Director shall sign travel expense vouchers of the Board members. The Chairman shall sign travel vouchers of the Executive Director.

## ARTICLE VII AMENDMENTS

These By-Laws may be amended, altered, changed, added to or repealed by the affirmative vote of the majority of the Board at any regular or special meeting of the Board.

## ARTICLE VIII EXPENSES

Members of the County Road Administration Board shall receive no compensation for their service on the Board, but shall be reimbursed for travel and other expenses incurred while attending meetings of the Board in accordance with Board Member Travel policy and section 10.70 of the Office of Financial Management State Administrative and Accounting Manual.

## ARTICLE IX DATE OF ADOPTION

These By-Laws have been reviewed and adopted by the County Road Administration Board on this 28<sup>th</sup> day of July 2016.

### County Road Administration Board – January 26, 2017 Regional RAP meetings update

Regional meetings were held in November 2016 through January 2017, in all regions.

Summary of items discussed:

- RAP account balance and spending (reimbursement) plans, project progress reporting.
- Suggestions for improvements to RAP Online.
- CARS and annual report status.
- Overview of RAP WAC rules.

All counties were reminded that, based on project demand and the current balance, the CRABoard may decide not to allocate funds to projects at the allocation meeting in April. Any new projects, if funded, would be programmed for RATA payout during the 2021 - 2023 biennium, and later. Bridge projects that become BRAC funded could be programmed earlier, if needed. The CRABoard will remove from the array any project that advertises for construction before RATA funds are approved.

The regions expressed satisfaction with the rating methods currently in place based on their September 2016 prospectus submittals.

Some of the engineers expressed dissatisfaction with the lack of funding support from legislature for the RATA program. Many counties would like to program more reconstruction type projects, but the RATA has not kept up with the need.

CRAB staff described the inconsistencies between counties' reporting of their spending plans, which are usually very optimistic, and actual project progress which often lags behind. Staff mentioned these two features would be linked in the next upgrade to RAP Online, to improve consistency. Spending plans for slow projects would likely be the first to be delayed if the account balance drops too low.

Counties were informed that the first run of the CARS system reporting of annual programs in December went well. February road levy certifications are coming in.

All projects submitted for new funding on the 2017 - 2019 biennium array were represented in the counties' six year programs submitted December 2016.

#### RESOLUTION 2017-001 APPORTION RATA FUNDS TO REGIONS

- WHEREAS RCW 36.79.030 establishes the Northeast, Northwest, Puget Sound, Southeast and Southwest Regions in Washington State for the purpose of apportioning Rural Arterial Trust Account (RATA) funds; and
- **WHEREAS** RCW 36.79.040 specifies the manner in which RATA funds are to be apportioned to the five regions; and
- **WHEREAS** the CRABoard established regional apportionment percentages for the 2015 2017 biennium at its meeting of July 16, 2015; and
- **WHEREAS** RCW 36.79.050 states that the apportionment percentages shall be used once each calendar quarter by the board to apportion funds credited to the rural arterial trust; and
- **WHEREAS** RCW 36.79.020 authorizes expenditure of RATA funds for costs associated with program administration;
- **NOW THEREFORE, BE IT RESOLVED** that the accrued amount of \$5,370,365 deposited to the RATA for <u>October</u>, <u>November and December</u>, <u>2016</u> be apportioned to the regions by their 2015 2017 biennium regional percentages after setting aside \$121,125 for administration.

### **Project Actions Taken by CRAB Staff – Quarter 4, 2016**

### Lincoln County's Rocklyn Road - RAP Project 2215-01 – change in milepost designation:

Lincoln County, per their letter dated December 23, 2016 requested a change in milepost designation for their Rocklyn Road Section 2 project, revising the milepost limits from 4.13 - 6.24 to 5.94 - 8.05. At the time of prospectus submittal and later RAP funding, the beginning of the road was located at the intersection with Coffee Pot Road. After RATA funding the limits were moved to the city limits of Harrington at SR 23, adding 1.81 miles to the road.

CRAB staff found the revision had no impact to the scope of work and cost for the RAP funded project. A contract amendment, revising the milepost designation was offered to and signed by the county.

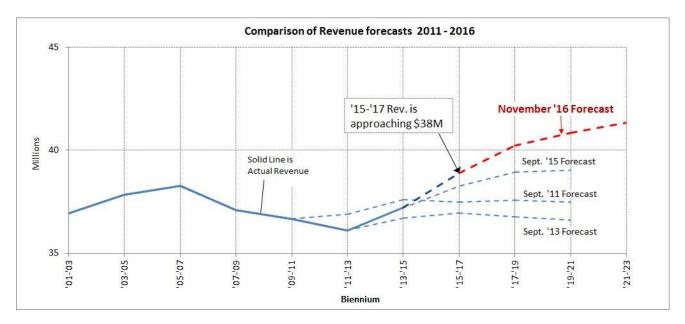
### County Road Administration Board – January 26, 2015 Information and Discussion: Potential Allocation to 2017 – 2019 biennium RAP Projects WAC 136-161-020

### **CRABoard consideration of allocation of RATA funds to projects in April:**

Per WAC 136-161-020 (6): "The county road administration board reviews the rank-ordered arrays in each region and, based upon the RATA funds projected to be allocable for the next project program period (see WAC <u>136-161-070</u>), selects and approves specific projects for RATA funding." In preparation for allocation of funding, which occurs April 27, 2017, the following should be considered:

#### Revenue estimate comparisons:

Revenue forecasts for the 2007 - 2009 through 2011 - 2013 biennia were overly optimistic since there was a downturn in revenue that followed in those three biennia. Beginning in 2013 however, the revenue has increased, though not as aggressively as earlier forecasts. Estimated '17 – '19 Rural Arterial Trust Account (RATA) revenue as of November 2016 is \$42,000,000, and includes \$500,000 in interest and the \$1,094,000 RATA share of last biennium's Connecting Washington fuel tax increase.



### Anticipated RATA balance:

Anticipated end of 2015 - 2017 RATA balance is \$18,700,000. Expected spending of RATA funds in 2017 - 2019 biennium is 45,000,000, based on the previous 5 years average. Since estimated revenue is about \$42,000,000, this will bring the balance down to around \$15,700,000 at the end of the 2017 - 2019 biennium (see table below). This balance will be lower or higher based on project accomplishment.

### Funding partially funded projects:

Current projects that are short funded by ~26,000,000\* RATA, would carry a total of 43,000,000 RATA if fully funded. The counties plan to spend 20,000,000 of this in 2017-2019, 20,000,000 in 2019 - 2021 and the remaining 3,000,000 later. These projects were funded initially in the last two years, and the counties would likely delay some of them (from 2017 to 2019 – 2020) if not fully funded this year. A delay would not force them into lapsing.

#### Funding new projects:

If the CRABoard chooses to fund new projects (after partially funded projects), the estimated amount of \$18,000,000 would be available for allocation, 14,000,000 in the first year of the biennium and 4,000,000 later (per WAC 136-161-070 (4), the CRABoard can allocate no more than 90% of estimated revenue in the first year of the biennium and the remainder "at such time as deemed appropriate" by the board). CRABstaff would schedule construction reimbursements for new projects in the 2021 -2023 biennium, ~ 4 years after approval. This 4-year period is typical for project-delivery times. Turned-back funds from withdrawals and underruns can be re-allocated at such time the CRABoard deems appropriate.

#### Summary:

The balance has dropped to \$14 M to \$15 M after every construction season for the last three years. This should continue, to greater degree, as a number of projects are awaiting the start of construction soon, particularly for Spokane County, which has \$14,250,000 of RATA funds (includes \$2,330,000 short funded on one project) obligated to Bigelow Gulch. The county plans to construct the projects in 2017 through 2020, in four sections.

Allocating to partially funded projects at the April 2017 meeting will assure the program continues without interruptions and maintains the forecast of expenditures as presented. Some of the projects could be delayed, if necessary, to maintain a \$12,000,000 balance. Any additional allocations to new projects could be made in the second year of the biennium (or later), after the outlook for estimated 2021 - 2023 project activity is clearer.

\*County limit capacity allows only ~23,000,000 to be allocated to partially funded projects on the new array.

The minutes also need to reflect any recommendations from the CRABoard to staff in response to the audits. This report details our staff procedures to satisfy the SAO.

CRAB has reviewed14 audit reports representing ten counties since the October 2016 board meeting. Four audits contained a total of four findings issued and none involved County Road Funds in some form. Any audits, with county name in bold print, revealed substantive findings involving County Road Funds, specifically:

### 136-12-010 Purpose and authority.

The laws of the state of Washington make detailed provisions in chapter <u>36.80</u> RCW, for the employment of a county engineer in each county. This chapter specifies that the county legislative authority of each county shall employ a county road engineer on either a full-time or part-time basis, or by contracting with another county for the engineering services of a county road engineer; that he/she shall be a registered and licensed professional civil engineer under the laws of this state; that he/she shall have supervision, under the direction of the county legislative authority, of all activities related to the county roads of the county, including maintenance; that he/she shall certify to the county legislative authority all bills with respect to county roads; that he/she shall keep complete public records of all road department activities; that he/she shall prepare plans and specifications for all construction work on the county road system ;give an official bond to the county conditioned upon faithfully performing all the duties and accounting for county property entrusted to him or her.

### **136-12-020 Procedure during vacancy or change.**

It is unavoidable that vacancies or changes will occur from time to time in the position of county engineer. When a vacancy or change occurs in the office of county engineer due to resignation, retirement, death or for any other reason, the county legislative authority shall take immediate steps to find a replacement, either by promotion from within the organization if a competent and eligible person is available, or by advertisement for, and interview of, qualified applicants. The county legislative authority or county executive shall, in writing, by electronic email or official letter, within five working days, notify the county road administration board of the vacancy or change, and of the procedure to be followed during the period of vacancy. The notice to the county road administration board shall state that the legislative authority or county executive has reviewed the requirements within this chapter.

### 136-12-030 Acting county engineer.

If for any reason, it is impossible to employ a new county engineer immediately, the county legislative authority shall designate, by resolution, an acting county engineer for an interim period, not to exceed six months, except as provided in WAC <u>136-12-060</u>. A copy of such resolution shall be forwarded to the county road administration board.

If the acting county engineer is not a licensed professional civil engineer, the legislative authority shall designate a licensed professional civil engineer to perform all engineering services during the interim period as required by chapter <u>18.43</u> RCW, and the acting county engineer shall perform only those functions of the office not requiring a professional civil engineer's license.

136-12-045 Notification of hiring. When final arrangements for the employment of a new county engineer have been made, the county legislative authority or the county executive shall, within five working days, notify the county road administration board in writing and shall include the following information: Name of new county engineer, Washington registration number, start date, and contact information, including an e-mail address if available. In addition, the notification shall include a copy of the organization chart detailing the responsibilities of the county engineer if there is an adopted change, WAC 136-50-051, and a copy of the appointment resolution, letter of appointment, or copy of the meeting minutes of the legislative authority recording the appointment. ### **136-12-060** Failure to comply.

In the case of vacancy or change, iIf notification is not received within the time frame established in WAC <u>136-12-045</u>, the matter of the vacancy will be considered at the next regular meeting of the county road administration board. The county road administration board may require that all construction by county forces projects be shut down and/or that all distribution of gas tax funds to the county cease: Provided however, tThat it may continue to grant reasonable extensions in the event the affected county can give adequate proof or demonstrate at the next regularly scheduled board meeting that a diligent effort has been made to secure the services of a qualified engineer.

# County engineer in counties that choose to employ a part-time county engineer or a contract county engineer.

When the county legislative authority chooses to employ a county engineer on a part-time basis the terms of such employment shall be set forth in a contract adopted by resolution of the legislative authority. Such contract shall specify, but need not be limited to: Statement of legal responsibility, salary or wage arrangements, meetings with the legislative authority, travel expenses and relationship with regular employees. A copy of such resolution and contract shall be forwarded to the office of the county road administration board.

When the legislative authority chooses to contract with another county for services such contract shall be approved by resolution of both legislative authorities. Such contract shall specify, but need not be limited to: Statement of legal responsibility, salary or wage arrangements, meetings with the legislative authority, travel expenses and relationship with regular employees. A copy of the contract and both resolutions shall be forwarded to the office

of the county road administration board. Any such contract shall be in accordance with the procedures of the Interlocal Cooperation Act, chapter  $\underline{39.34}$  RCW.

# 136-12-080 Assistant county engineer in counties with a part-time county engineer or a contract county engineer.

When a legislative authority of a county chooses to employ a licensed professional civil engineer on a part-time basis or contract with another county for the services of its licensed professional civil engineer, it shall designate by resolution a full-time employee as assistant county engineer. In such cases, the designated assistant county engineer shall perform the day to day supervision of the road department under the county engineer in accordance with policies established by the legislative authority.

### 136-18-010 Purpose and authority.

# **136-18-020 Definitions.**

For purposes of implementing statutory requirements relative to construction by county forces, the following definitions shall apply:

(1) Construction - The building of a new road facility or improvement of an existing facility to a higher geometric or structural standard.

(2) Construction by county forces - Construction work performed by personnel carried on the county payroll using county owned, leased or rented equipment.

(3) Authorization date - The date that construction is authorized.

(4) Start of construction - The date that construction work commences.

(5) End of construction - The date that construction work is completed.

(6) Completion date - The date on which a county road project is closed in the accounting records.

(7) Estimated construction costs - The county engineer's estimate of the cost of contemplated construction work, not including preliminary engineering and right of way acquisition costs.

(8) Estimated project costs - The county engineer's estimate of the cost of engineering, right of way acquisition, and construction.

(9) True and complete construction costs - The accounting record of all construction costs attributed to a county road project from the authorization date to the completion date.

(10) True and complete project costs - The accounting record of all engineering, right of way acquisition, and construction costs attributed to a county road project from the authorization date to the completion date.

(11) Construction by county forces road project - Construction by county forces authorized by action of the county legislative authority in those counties where a cumulative dollar limit applies to all construction by county forces.

### **136-18-030** Authorization of construction by county forces projects.

Every proposed construction by county forces road project shall be a part of the county's annual construction program as defined in RCW <u>36.81.130</u> and WAC <u>136-16-020</u>. Additions to the program, and/or substitutions in the program, may be made by unanimous action of the county legislative authority at any time as provided in RCW <u>36.81.130</u>. No construction work shall be done on any project until it has been authorized by resolution of said authority. The resolution shall include:

(1) A brief description of the project;

(2) A vicinity map showing the location of the project and its limits, provided that in lieu of individual vicinity maps, a single vicinity map showing the location of all projects may be included with the resolution adopting the annual program;

(3) Identification of the project in terms of the officially adopted annual program;

(4) The county engineer's estimate of construction costs prepared pursuant to the completion of such preliminary engineering; and

(5) Construction plans as shall be necessary and sufficient.

### **136-18-064 Preconstruction publication requirements.**

At its second regular meeting of each calendar year, the county road administration board shall determine if any county has unreasonably exceeded its statutory construction by county forces limit for the preceding calendar year, as indicated in RCW <u>36.77.065</u>. In determining what is unreasonable, the county road administration board shall consider the following:

(1) Did the county provide prior notification of the possible construction by county forces limit violation in writing to the county road administration board?

(2) What is the amount of the excess construction by county forces expenditure compared to the total annual county road construction expenditure for the same time period?

(3) Are there extenuating circumstances beyond the control of the county that resulted in exceeding the statutory construction by county forces limit?

(4) What is the past record of the county regarding construction by county forces compliance?

## **136-18-090** Action on construction by county forces compliance by the county road administration board.

Determination by the county road administration board that a violation of RCW <u>36.77.065</u> has occurred shall be cause for issuance of a conditional certificate of good practice by the board as specified in WAC <u>136-04-060</u> on behalf of the county in which the violation occurred. The first condition of such a conditional certificate of good practice shall be that the county be required, at the next regular or special meeting of the county road administration board, to show cause why a certificate of good practice should not be denied to that county. ### County Ferry Capital Improvement Program (CFCIP) - WAC 136-400 Project Application Guidance

### General:

The following CFCIP project application guidance summary is not intended to replace or otherwise amend the language of WAC 136-400. Implementation of the CFCIP, including all critical dates and performance standards, will be based entirely on the current version of WAC 136-400.

The CRABoard reserves to itself the exercise of discretion as allowed in WAC 136-400.

### County Eligibility:

- Counties eligible to apply for county ferry capital improvement funds are Pierce, Skagit, Wahkiakum, and Whatcom.
- For the project to be eligible it must be included in both the county's six-year transportation program and its ferry system fourteen-year long range capital improvement plan.
- Any county holding an approved and executed county ferry capital improvement program contract is ineligible to submit a project funding application for additional ferry capital improvement funds until the existing contract is fully performed or has been mutually terminated.

### Eligible Projects:

- Purchase of new vessels
- Major vessel refurbishment (e.g., engines, structural steel, controls) that substantially extends the life of the vessel
- Facility refurbishment/replacement (e.g., complete replacement, major rebuilding or redecking of a dock) that substantially extends the life of the facility
- Installation of items that substantially improve ferry facilities or operations
- Construction of infrastructure that provides new or additional access or increases the capacity of terminal facilities

Year A = 2016, 2020, 2024, etc. Year B = 2017, 2021, 2025, etc. Year C = 2018, 2022, 2026, etc. Year D = 2019, 2023, 2027, etc.

Note: The following procedural steps require an affirmative action to take place in order for the subsequent step to proceed

### Year A (or earlier) actions:

- Project planning and engineering adequate for:
  - o inclusion in 6-year and 14-year documents and their adoption
  - o creation of a county ferry district (subject to counties financial plan)
  - submission of project funding request to the Public Works Board or any other available revenue source

### Year B actions:

- County requests CRABoard to issue call for projects at Spring meeting
- CRABoard may act on a call for projects at the Spring meeting, but must act on request no later than Summer meeting
- If a call for projects is approved, project applications must be submitted no later than December 31st

### Year C actions:

- Technical Review Committee completes its review and develops a written report no later than 30 days prior to the CRABoard Spring meeting
- CRABoard reviews the committee report and may act at the Spring meeting, but must act no later than Summer meeting
- If approved by the CRABoard, a CFCIP project funding request is included in the CRAB agency biennial budget request submitted late summer

### Year D actions:

- State Legislature reviews CRAB CFCIP budgetary request
- If approved by the Legislature and Governor, CFCIP funds available for project expenditures beginning July 1st, or upon execution of the CRAB/County contract, whichever occurs last

### STANDARDS OF GOOD PRACTICE

### Vacancy in Position of County Engineer:

*Grays Harbor County* – Joe Seet, PE served his last day as the Grays Harbor County Engineer on an unknown date prior to October 31, 2016. The County informed the CRABoard of the appointment of Rob Wilson, PE as County Engineer on October 31, 2016 in reasonable compliance with WAC 136-12.

*Stevens County* – Jim Whitbread, PE served his last day as the Stevens County Engineer on December 15, 2016. The County informed the CRABoard of the vacancy on December 20, 2016 in accordance with WAC 136-12. The county has named Assistant County Engineer, Jason Hart, as the Acting County Engineer while they recruit for a new County Engineer.

### County Audits – For Fiscal Year 2015

Since the last CRABoard meeting there have been no new county audit Findings regarding compliance issues.

**Skamania County:** CRAB staff has been monitoring a continuing Finding which effects the Road Fund. For at least four consecutive audits, the SAO has issued a Finding that the county's financial condition continues to decline and is at risk of not being able to meet its current obligations and maintain services. SAO reports this issue only partially resolved per the 2015 audit. CRAB staff continues to support county Public Works staff on a consultative basis.

### December 31, 2016 Submittal Requirements

Annual Construction Program, Six Year Transportation Improvement Program, CAPP program, PMS Certification, Road Fund Budget Summary, Maintenance Management Work Plan and Budget, County Engineer's Certification Form.

This was the first reporting to CRAB by the counties through the new online reporting tool C.A.R.S. The system worked surprisingly well and the counties took right to the new application. Thank you to Eric Hagenlock, Kathy O'Shea, and Jim Oyler for their hard work on this.

All the above forms and reports required to be submitted to CRAB by December 31, 2016 in order to maintain the Standards of Good Practice have been submitted on time by 38 of the 39 counties. Clallam County, due to a personnel issue, requested an extension and was granted until January 6 to submit one outstanding submittal. That deadline was not met but did submit on January 10.

### **Cooperative Procedures for Processing of County Road Accident Reports**

All counties are required by WAC 136-28 to have responded to/processed at least 90% of the county road collision reports submitted to them for coding by December 31 of each calendar year. For 2016, 36 of 39 counties were compliant as required with the three remaining counties, Ferry and Garfield becoming compliant on the sixth and ninth respectively, and Clallam on the 18th.

### County Road Log

RCW <u>46.68.124(2)</u> provides that the county road administration board shall maintain the county road log for the purpose of computing estimated county road replacement costs and estimated annual maintenance costs for county fuel tax allocations. It further provides that each county shall submit changes, corrections, additions, and deletions (i.e., "updates") to the county road administration board which in turn are subject to validation prior to inclusion in the road log maintained by the county road administration board. This chapter describes the manner in which the county road administration board will administer this responsibility.

All counties are required by WAC 136-60 to maintain an accurate and up to date inventory of their county road systems, the Road Log. CRAB became aware in June of 2015 that Okanogan County had some significant issues with the validity of their Road Log. The County was given the expectation by the Executive Director that they adopt a valid Road Log by December 31, 2016. The County failed to make that deadline.

Per the SAO's recommendation, I hereby certify that I have reviewed all of the above compliance reporting with the Deputy Director.
