CALL TO ORDER

Chair Stacy called the meeting to order at 10:00 am. He requested that all virtual attendees mute their audio unless speaking, and that everyone silence their electronics.

CHAIR'S REPORT

Approve October 29, 2020 Agenda

Commissioner Ross moved and Commissioner Koch seconded to approve the agenda as submitted. **Motion carried unanimously.**

Approve Minutes of July 30, 2020 CRABoard Meeting

Commissioner Koch moved and Commissioner Ross seconded to approve the minutes of the July 30, 2020 CRABoard Meeting. **Motion carried unanimously.**

Set 2021 CRABoard Meeting Dates

Chair Stacy noted that staff is presenting two options for future meeting dates, either staying with the traditional two-day meeting format, or changing to one-day only meetings.

Following questions and discussion, the Board opted to continue to schedule two-day meetings. Commissioner Ross moved and Second Vice-Chair Janicki seconded to set the 2021 meeting dates as January 28-29, April 29-30, July 29-30, and October 28-29. **Motion carried unanimously.**

EMERGENCY LOAN PROGRAM REQUESTS

Mr. Johnson noted that typically these requests would be reviewed and possibly approved by the Executive Director, as authorized by WAC 136-500-090. However, due to the receipt of a request for additional funds from Columbia County, which requires Board approval, staff is requesting that the CRABoard weigh the merits of both requests to determine the amount of funding and loan terms for one or both requests.

Columbia County

Mr. Johnson reported that Columbia County experienced significant flooding in early 2020 and requested a \$1,000,000 loan from CRAB's Emergency Loan Program (ELP). The Executive Director approved a \$500,000 loan contract which was executed in March 2020. The funds have been transferred and put to use in the emergency response.

The total damage assessment is \$7,200,000. Columbia County will be responsible for \$1,300,000 if all anticipated funding is received. WAC 136-500-090 allows the County to request additional ELP funding, beyond what was originally awarded. The maximum additional request amount is limited to the remaining funds in the account, which is \$511,782.81.

The additional ELP fund request will be used for gap financing for the flood repairs until FEMA and FHWA funding becomes available, cover flood repair costs not covered by federal agencies, and provide match funding for outside funding reimbursements, which are allowable uses per WAC.

Mr. Johnson also noted that Columbia County has requested that this additional loan contract, if awarded, have a 36-month payback schedule to assist with cash flow limitations. Currently the county is budgeting for a reduction of \$1,800,000 over the next two years out of an operations and administration budget of \$3,600,000 per year. The extension of the new loan to a three year period will alleviate further reductions, except for a 14% reduction in the third year. This assumes no additional COVID revenue reductions beyond 2020.

Columbia County currently has five active RAP-funded projects. Several projects have been delayed due to factors that include the flooding disaster and its repercussions. The request for additional emergency loan funds by Columbia County meets the requirements of WAC 136-500 with the exception of the payback terms. WAC 136-500-080 states that any loan funded through this program shall have a term not to exceed twenty-four months.

Mr. Johnson reported that staff supports Columbia County's emergency loan request, but defers to the Board for a decision regarding the payback term and loan amount.

He introduced Mr. Eaton and Commissioner Amerein, who provided further information to the Board.

The Board asked to hear the Franklin County request before taking any action.

Franklin County

Commissioner Koch recused himself from discussion and voting on the Franklin County request.

Mr. Johnson reported that on September 6-7, 2020, a wildland fire burned through the east portion of Franklin County, causing significant damage to Burr Canyon Road, including the loss of approximately 13,000 linear feet of guardrail and the destruction of a small span structure.

The estimated cost to repair this damage is \$1,450,000. In order to support the County's response efforts, Franklin County has requested ELP funding to be used for temporary and permanent repairs to the damage caused by the wildland fire.

Mr. Johnson noted that staff also supports Franklin County's emergency loan request, but defers to the Board regarding the loan amount to provide, due to multiple loan requests and insufficient total funding.

He introduced Mr. Erdman, who gave further information to the Board.

Following questions and discussion, Mr. Storey moved and Commissioner Ross seconded to loan Franklin County \$200,000 and to loan Columbia County the remainder of the funds in the account, both with a 24 month payback term. **Motion carried unanimously, with Commissioner Koch recused.**

Staff will finalize the resolutions for the two ELP requests and bring them back to the Board for adoption.

RURAL ARTERIAL PROGRAM

Program Status Report

Mr. Johnson reviewed the Rural Arterial Program status report, noting that 1,097 of

1,223 projects have been completed, and 13 are awaiting closeout. Anticipated revenue to the end of the 2019-21 biennium is \$646,727,559. RAP expenditures to date total \$615,632,469. RAP obligations remaining to active projects through the 2019-2021 biennium total \$134,054,651. The RATA fund balance as of September 30 was \$15,785,255.

Revenue has been significantly reduced due to decreased fuel sales. However, county projects were also slowed down, so the RAP balance has not drawn down as far as expected. Counties are being encouraged to proceed with construction when possible.

Mr. Johnson shared some before and after views of recently completed projects.

Resolution 2020-008 - Apportion RATA Funds to Regions

Mr. Johnson presented Resolution 2020-008 - Apportion RATA Funds to Regions, which authorizes that the accrued amount of \$3,912,435 deposited to the RATA for July, August and September 2020 be apportioned to the regions by the established 2019-21 regional percentages after setting aside \$192,543 for administration.

Following questions and discussion, Commissioner Koch moved and Commissioner French seconded to approve Resolution 2020-008 - Apportion RATA Funds to Regions. Motion carried unanimously, with Commissioner Ross abstaining as he was out of the room during the discussion.

Columbia County Project Request

Mr. Johnson reported that Columbia County has requested an additional construction time extension for the RAP funded Lower Hogeye Road project. The project will currently lapse on April 18, 2021. The county has already received a two year construction time extension. WAC 136-167-040 (5) allows that "The CRABoard may in its discretion determine that for the public safety, health or general welfare, an additional extension is necessary." The county therefore requests the CRABoard take additional action to extend the lapsing date two years further, to April 18, 2023.

Mr. Johnson gave a brief summary of the project's background and development to date. If the extension is not granted, Columbia County will have until April 18, 2021 to bring this project to the construction phase, or withdraw the project.

Staff recommends an additional construction lapsing extension of Columbia County's Lower Hogeye Road RAP project to April 18, 2023.

Mr. Eaton provided further information on the request.

Following questions and discussion, Mr. Storey moved and Second Vice-Chair Janicki seconded to approve an additional construction lapsing extension of Columbia County's Lower Hogeye Road RAP project to April 18, 2023. **Motion carried unanimously.**

Proposed Technical Changes to WAC 136-500

Mr. Johnson presented staff's proposed change to WAC 136-500-080, specifying that the interest charged on a loan from the Emergency Loan Program be calculated as simple interest. He noted that if the Board concurs, the next step is for the Board to set a Public Hearing on the matter and for staff to file a CR-102 with the Office of the Code Reviser.

The Board raised the question of amending the WAC to extend the 24-month term of repayment.

Following questions and discussion, the Board tabled the matter for staff to draft a new proposal.

2021-23 RAP Priority Array Review

Mr. Johnson presented the proposed arrays for each of the five RAP regions, noting that the counties submitted 135 preliminary proposals on March 2, 2020. CRAB engineering staff field reviewed these preliminary submittals in the spring of 2020 with the county engineer or responsible staff to evaluate surface conditions and discuss overall scope of each of the proposals.

Mr. Johson reported that 75 final prospectuses were received from the counties on September 1, 2020 requesting \$103,132,800 in RATA funding in the 2021-2023 biennium. In comparison, 79 prospectuses requested \$110,054,200 in the current biennium.

The estimated revenue for the 2021-2023 biennium is \$45,000,000, which includes \$4,844,000 Connecting Washington funding. Including the Connecting Washington funding, though not codified in CRAB's budget, in the estimate for the call for prospectuses ensures the Board has a large array that can direct all potential funding to the most competitive projects in each region.

CRAB staff will review the 2021-2026 Six Year Program submittals for each county early in January to assure proposed RAP projects are included in those programs.

RATA Fund Balance Review

Mr. Woods gave a brief presentation outlining how current financial trends may affect the RATA fund balance in the near future. He noted that the Board should still be able to approve some funding for the next proposed array of projects. Current reimbursement schedules could result in CRAB having to delay reimbursements to counties in 2021 and 2022.

Chair Stacy called a 20 minute recess to allow the Board and staff to prepare for the working lunch. The meeting resumed at noon.

WSACE UPDATE

Ms. Wall reported that the WSACE has been working on their priorities for the upcoming legislative session. They have updated their Statement of Policy to identify the possible transportation revenue sources they would or would not support. They will support a replacement for the MVFT if it is constitutionally protected by the 18th amendment. She noted that the current plan is for the legislative session to be held virtually rather than in person.

Ms. Wall has been attending several listening sessions and workgroups held by Representaive Fey and Senator Saldana regarding transportation funding. She noted that Senator Hobbs has been largely absent from legislative service since March, due to his responsibilities with the National Guard.

She reported that the County Leaders' Conference November 18-20 will be held virtually. The WSACE will have its own track at the conference, with breakout sessions and a roundtable discussion. That same week, the counties will be presenting to the Joint Transportation Committee.

TABLED ITEMS

Resolution 2020-009 Franklin County Emergency Loan Request

Commissioner Ross moved and Second Vice-Chair Janicki seconded to approve Resolution 2020-009 Franklin County Emergency Loan Request, which offers the county an emergency loan of \$200,000, to be paid back over 24 months at simple interest. **Motion carried unanimously, with Commissioner Koch recused.**

Resolution 2020-010 Columbia County Emergency Loan Request

Second Vice-Chair Janicki moved and Commissioner Ross seconded to approve Resolution 2020-010 Columbia County Emergency Loan Request, which offers the county an emergency loan of the remaining amount available in the fund as of October 31, 2020, to be paid back over 24 months at simple interest. **Motion carried unanimously.**

Technical Changes to WAC 136-500

Commissioner Ross moved and Commissioner Koch seconded to add language to WAC 136-500 to specify that loan interest will be charged as simple interest; to add language allowing a county currently receiving a loan from the ELP to petition the Board to extend the length of payback term; and to set a Public Hearing on the changes for January 28, 2021 at 2:00 pm. **Motion carried unanimously.**

EXECUTIVE DIRECTOR'S REPORT

Approve Annual Certification Form

Mr. Koster presented the Annual Certification Form for Calendar Year 2020, noting that there were no changes other than updating dates.

Following questions and discussion, Commissioner Ross moved and Second Vice-Chair Janicki seconded to approve the Annual Certification Form for Calendar Year 2020. **Motion passed unanimously.**

Director's Activities

Mr. Koster reported on his activities since the July 2020 CRABoard Meeting. **DEPUTY DIRECTOR'S REPORT**

Current Budget Status

Mr. Woods reported that the agency is on track to end the biennium with a \$500,000 surplus. Staff plans to identify items such as software license renewals that could be purchased early, therefore saving funds in the next biennium. He reminded the Board that any unused funds at the end of the biennium are returned to the counties through RAP and CAPP.

2019-21 Supplemental Budget Request

Mr. Woods noted that staff submitted a request for \$122,000 to assist in the five retirement payouts occurring in this fiscal year.

2021-23 Budget Submittal

Mr. Woods reported that the agency has requested approximately \$61,000,000 for RAP, which includes \$4,800,000 in Connecting Washington funds and \$600,000 in electric vehicle licensing fees. A request was made for approximately \$46,000,000 for CAPP, which includes \$3,000,000 in transfers from the Transportation Partnership Account and \$4,800,000 in Connecting Washington funds. Other requests included \$1,500,000 for the County Ferry Capital Improvement Program and a one-time deposit of \$10,000,000 to the Emergency Loan Program fund.

The Office of Financial Management asked all state agencies to identify potential cuts of 10% to the 2021-23 biennium if needed. Potential savings for CRAB include delaying the filling of two vacant positions and reducing information technology spending, as well as reduced travel expenses.

Mr. Woods noted that full documentation of both the 2019-21 Supplemental Budget Request and the 2021-23 Budget Submittal is available upon request, and also posted on the OFM website.

Deputy Director's Report

Mr. Woods noted that Kittitas County notified CRAB that Joshua Frederickson, P.E., has received his engineering license to practice in Washington State and thus assumed all of the duties of county engineer effective September 29.

He reported on official visits to Skagit County, Pacific County, Ferry County and Stevens County. Due to COVID-19, all other county contacts were by phone, email and virtual meetings.

Mr. Woods noted that on August 4, he and Mr. Koster were honored to present Paul Randall-Grutter from Skagit County with the County Engineer of the Year Award. Normally CRAB would present this award at the June WSACE conference.

He reviewed a list of his activities since the April 2020 CRABoard meeting.

ENGINEERING AND ADMINISTRATIVE SUPPORT SERVICES

Compliance Report

Mr. Pohle reported that Asotin County, Lincoln County and Pacific County are actively recruiting for the position of County Engineer. Both Asotin County and Lincoln County have hired Walt Olsen, PE, as the Interim County Engineer. Ferry County has appointed Nicole Norvell, PE, as their County Engineer.

Mr. Pohle noted that upon review of the organizational charts submitted by the counties in April as required by the Annual Certification form, the charts of five counties indicated potential noncompliance with regard to command and control of county road maintenance. Staff worked with those five counties to correct and/or modify their charts to come into compliance.

State Auditor's Report

The 1997 State Auditor Office (SAO) audit of CRAB concluded that the minutes of the Board meetings needed specific mention of SAO audits of the counties and of any findings that might relate to the statutory responsibilities of CRAB. The minutes also need to reflect any recommendations from the CRABoard to staff in response to the audits. This report details our staff procedures to satisfy the SAO.

EASS Report

Mr. Pohle reported on an official visit to Pacific County for consultation regarding their Public Works Director/County Engineer position. He also met with new County Engineers in Kitsap, Grant and Mason Counties. He logged 48 contacts with 24 counties, seven with other agencies, and two with the public since the July 2020 CRABoard Meeting.

Mr. Pohle noted that he is updating the manual for upcoming County Engineer's training. Classes are being offered in December and January. There will be reduced class size due to social distancing requirements.

He reported on his other activities since the July CRABoard meeting.

Information Systems

Mr. Hagenlock reported that all major projects are within scope and on budget. CRAB's largest project, GIS-Mo, has been slightly behind schedule since July, but with no expected impacts to Go-Live in January.

Staff has been working on CRAB's disaster recovery plan. He noted that to accomplish this effort successfully requires careful planning, rapid implementation, and sustainability.

He reported that the CRAB/FMSIB website migration to WaTech has completed development, testing, and training. Both agencies are working to update dependent applications before final migration. This effort will move 60%-70% of an employee's workload to WaTech and give all CRAB staff control over the agency's website content.

Mr. Hagenlock noted Office365 onboarding continues to progress, although not as quickly as staff would like. Staff will monitor systems and security workload and the potential need for additional resources.

He noted that the IT staff has been reorganizing their duties, with Mr. Young and Mr. Campbell absorbing database development duties in preparation for Ms. O'Shea's retirement in March. Staff is evaluating the needs for system and security support, has completed a 2021-2023 budget analysis and compiled their Strategic Plan Performance Measures.

Mr. Hagenlock noted that many major milestones have been reached in the Strategic Plans for GIS-Mo, the CRAB website, Office 365 migration, Cloud migration, and a new release for 2021-2023 call for projects in RAP Online.

He reported on ongoing system security updates and staff training and development.

Design and UAS Systems

Mr. Bailey noted that the contract for a \$101,000 grant from the Washington Traffic Safety Commission for the implementation of a Learning Management System (LMS) was finalized and the LMS has been implemented. CRAB and Eagle Point offered four LMS training webinars for county administrators and prepared two kick-off training webinars for users. The user kick-off training webinar was attended by 195 users, 36 of the counties have provided user databases totaling 560 users, the first day of operation saw 199 users log in, and users accessed 390 assets within the platform. He will monitor the usage of the portal and have reports for future Board meetings.

Mr. Bailey noted that no in-person learning has been held or is scheduled for this upcoming quarter due to lingering COVID concerns and restrictions.

He has assumed responsibility for production of training videos for the GIS-Mo rollout, a task previously headed by Jim Oyler, who retired in September.

Mr. Bailey reported that the UAS Program had its first official mission with the quad-copter on September 29, assisting Skagit County in collecting data on Francis Road. Staff has been in conversation regarding the use of the UAV for a variety of data collection tasks and plans to begin looking more closely at the feasibility of using the UAV for tasks that would bring value to the counties. These include roadway topography, such as the Francis Road Project, road rating and asset collection. Staff will assess the drone's current camera payloads and need for new equipment as necessary to accomplish the tasks. It is their intent to fund this endeavor through upcoming grants.

Executive Director Recruitment Timeline

Mr. Stacy presented a possible timeline for recruitment of a new Executive Director and the current position description. The Board determined that the Executive Team will review the position description and salary and make recommendations to the full Board. The Board will finalize the description and salary in November, advertise in January 2021, and interview in March. Mr. Koster will retire April 30, 2021, and the new director would begin on May 1.

New CRABoard Member

Chair Stacy welcomed Franklin County Commissioner Brad Peck, who has been appointed by WSAC to replace Commissioner Koch. He introduced himself to the Board.

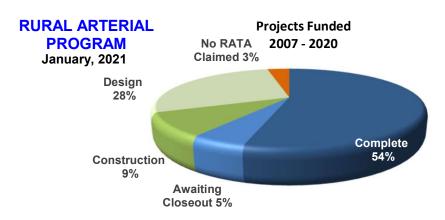
Recognition Presentations

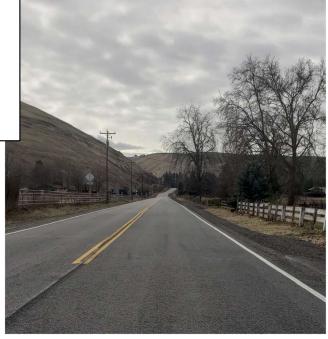

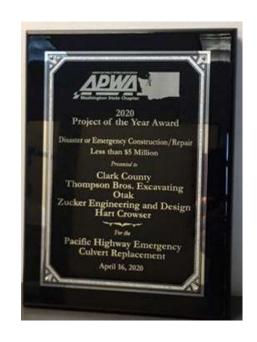

County Road Administration Board – January 28, 2021 Regional RAP meetings update

Regional meetings were held in November and December, 2020. Topics covered:

- Funding and project status for the RAP program, as summarized on the RAP Program Status Report. Counties were encouraged to close out projects that have completed construction.
- RAP balance impacts and forecasts based on continued pandemic and shutdown effects.
 Revenue has been somewhat reduced, however many County projects were also slowed down, so the RAP balance did not draw down as far as expected. Counties were encouraged to continue project work as possible.
- Mike Clark reviewed the 2021 CAPP and MVFT revenue estimate
- Mike also reminded the Counties of the Mobility / GIS-Mo transition, emphasizing that CRAB staff will be ready for any technical assistance needed during the transition period.
- Reviewed the 2021-2023 project arrays, and reminded all counties to ensure that all CRAB projects, whether active or proposed, need to be on their 6-year Transportation Improvement Program list.
- Presented the RAP Online reimbursement schedule modification unspent funds will no longer roll forward at the turn of the quarter. Instead, unspent funds will need to be rescheduled. County staff appeared to understand and support the change.
- Brief discussion of FLAP 2020 call for projects applications were due December 2020, and are expected to be reviewed in early 2021.
- Reviewed all active projects for general status, specifically to assess timing for construction.
- Reviewed the Emergency Loan Program, updating all counties on the status of the fund- after three loans being offered to support two counties, the account is currently fully loaned out \$0.78 remaining. We are requesting additional funding for this program from the legislature, due to the obvious demonstrated need.
- Presented several WAC change proposals, including the Emergency Loan (WAC 136-500) change that has been presented to the CRABoard, and several additional proposed WAC clarifications that have not yet been presented to the Board.

RESOLUTION 2021-001 APPORTION RATA FUNDS TO REGIONS

WHEREAS RCW 36.79.030 establishes the Northeast, Northwest, Puget Sound, Southeast and Southwest Regions in Washington State for the purpose of apportioning Rural Arterial Trust Account (RATA) funds; and

WHEREAS RCW 36.79.040 specifies the manner in which RATA funds are to be apportioned to the five regions; and

WHEREAS the CRABoard established regional apportionment percentages for the 2019 - 2021 biennium at its meeting of July 25, 2019; and

WHEREAS RCW 36.79.050 states that the apportionment percentages shall be used once each calendar quarter by the board to apportion funds credited to the rural arterial trust account; and

WHEREAS RCW 36.79.020 authorizes expenditure of RATA funds for costs associated with program administration;

NOW THEREFORE, BE IT RESOLVED, that the accrued amount of \$5,623,531 made available in the RATA in <u>October, November, and December 2020</u> be apportioned to the regions by their 2019-2021 biennium percentages after setting aside \$209,529 for administration.

County Road Administration Board – January 28, 2021

Project Actions Taken by CRAB Staff

I. Island County – RATA Reimbursement for Boon Road (1514-01)

Island County's Boon Road 3R project has been completed. The estimated \$3 million project came in under estimate, which will allow a RATA fund turnback when the project is closed out.

While reviewing final paperwork for the project, County staff discovered an accounting issue that resulted in over billing CRAB RATA funds. The issue involves charging indirect overhead costs on top of staff labor, consultant, and construction work performed on the project. After several discussions with CRAB, Island County completed their review of the accounting, removed the indirect overhead costs charged on the project, and provided documentation of the corrections, which CRAB staff reviewed and acknowledged. The County then reimbursed the RATA funds, in the amount of \$203,501.21. The reimbursed funds were deposited back into the Island County Boon Road project, and will be included with the RATA fund turnback when the project is closed out.

II. Spokane County – Scope Changes for Bigelow Gulch projects (3298-01 and 3215-01)

Spokane County requested a scope change for each of their remaining Bigelow Gulch projects. The changes being requested are to correct the beginning and ending mileposts for each project. Over the life of the projects, and other Bigelow Gulch corridor improvements, there have been slight modifications and adjustments to their project scopes. The requested scope changes for these two projects will bring the RAP contracts in line with the Spokane County 6-Year Plan.

Spokane County is not requesting additional RATA funding for the additional project length. The minor length adjustments resulted in a small change in the overall project rating score, however did not alter the project positions in the funding arrays. The director forwarded a letter on January 8, 2021 with a contract amendment for the change in scope for each project.

III. Revised RAP Arrays

After review of the six-year road programs submitted by the counties on December 31, 2018, CRAB staff found four projects that were submitted on the proposed array (reviewed at the October 2020 CRABoard meeting) but were not included on the six-year programs.

ADDITIONAL CONSTRUCTION LAPSING TIME EXTENSION

ELOCHOMAN VALLEY RD AND CLEAR CREEK FISH PASSAGE, MP 6.10– 6.60
WAHKIAKUM COUNTY RAP PROJECT 3515-04

I. Nature of Request:

Wahkiakum County has requested, per its January 11, 2021 letter, an additional construction time extension for the RAP funded Elochoman Valley Road and Clear Creek Fish Passage project. The project will currently lapse on April 16, 2021, after the county already received a 2-year construction time extension for the original 3R portion of this project, which was combined with the Clear Creek project in March 2017. CRAB's WAC 136-167-040 (5) allows that "The CRABoard may in its discretion determine that for the public safety, health or general welfare, an additional extension is necessary." The county therefore requests the CRABoard take additional action to extend the lapsing date two years further, to April 16, 2023.

II. Background:

The Elochoman Valley Road 3R project was submitted for funding in August 2008, requesting \$864,000 in RATA funding. The CRABoard allocated \$817,730 in RATA funding in April, 2009, and the final \$46,270 to full funding in April, 2010. The project proposes to enhance the safety of this roadway by improving horizontal and vertical curves, strengthening the subgrade, and widening the paved section to provide 12-ft lanes.

The Clear Creek Fish Passage project was submitted for funding in August 2014, requesting \$500,000 in RATA funding. The CRABoard allocated \$278,028 in RATA funding on April 16, 2015. The project proposes to replace the poor condition Clear Creek culvert under Elochoman Valley Road with a bridge allowing improved fish passage. This project is partially funded, through design, by the Salmon Recovery Funding Board. Additional construction funds from the Salmon Recovery Funding Board are still being pursued.

The two projects were combined in March 2017. The CRABoard allocated the final \$221,972 in RATA funding in April 2017, bringing the fully funded combined RATA authorization to \$1,364,000.

To date, the county has received \$232,666.24 in RATA reimbursements for design of the project.

III. Project development:

A. First lapsing occurrence:

The original construction lapsing date for the original Elochoman Valley Road was April 16, 2015, six years after CRABoard approval of funding. An extension to April 16, 2017 was requested by the county on January 23, 2015 citing loss and turnover of key county staff necessary for project development. This request was approved by the CRAB director on January 27, 2015.

B. Project Combination:

The act of combining the two projects – Elochoman Valley Road, and the Clear Creek Fish Passage Project brought both projects into the same contract. This allowed the combined project lapsing date to remain as April 16, 2021, six years after CRABoard approval of funding for the Clear Creek Fish Passage project, which is the second project's original construction lapsing date.

C. Second lapsing occurrence:

The second lapsing date will arrive April 16, 2021 and the county has requested an additional extension. The County planned to complete the design of the project for construction in 2021.

The County's design consultant has completed the 90% design, providing a construction cost estimate that remains significantly over the available budget. The County has been pursuing additional construction funding, specifically from the Salmon Recovery Funding Board via the Recreation Conservation Office. The County is also intending to modify the construction phasing to allow initial site preparation efforts using County Forces. This will help to reduce the construction contract costs.

While the County pursues the additional funding, and adjusts their construction plans, they acknowledge that they will not be able to meet the April 2021 construction lapsing date requirement. In consideration of these circumstances the county requests an additional extension of construction lapsing to April 16, 2023.

IV. Pertinent WAC language:

WAC 136-167-040 Lapsing of RATA allocation for approved projects.

- "....(3) If an approved project does not meet a required project development milestone, the county road administration board will, at its next regular meeting, withdraw RATA funds from the project.
- (4) At any time up to ten days before such meeting, the county may, in writing, request an extension of the lapse date. The county road administration board may grant such an extension if it finds that the delay in project development was for reasons that were both unanticipated and beyond the control of the county, and subject to the following:
- (a) A project extension will be granted one time only and will be no more than two years in length; and
- (b) The county can demonstrate that the project was actively pursued for completion within the original CRAB/county contract terms and can be completed within a two year extension; and
- (c) The request for an extension is based on unforeseeable circumstances that the county could not have anticipated at the time the project was submitted for RATA funding; and
- (d) An approved time extension will not be grounds for the county to request an increase in the RATA funding of the project; and
- (e) The executive director will determine a new lapse date, and all of the requirements listed above under subsections (1) and (2) of this section will apply except that further extensions will not be granted.
- (5) The CRABoard may in its discretion determine that for the public safety, health or general welfare, an additional extension is necessary. If such a determination is made, the CRABoard may grant an additional extension and set the duration thereof."

V. Staff Analysis and Recommendation:

The CRABoard must decide whether to grant the additional time extension for the Elochoman Valley Road and Clear Creek Fish Passage project as requested by the county. If the extension is not granted, Wahkiakum County will have until April 16, 2021 to bring this project to the construction phase, or withdraw the project. Withdrawal of the project will require the payback of RATA funds, following WAC 136-167-030.

Staff finds:

- The County has demonstrated intent to construct both original projects in a manner that will minimize disruption to residents and road users, and allow efficient construction.
- While the 3R project has been extended previously, this is the first extension request for the Fish Passage project.
- The County is actively pursuing the additional construction funding.

- This project does not meet the requirements for consideration of RATA fund increase (WAC 136-165-020) since it has already been awarded the maximum amount allowable for Drainage Type projects in the Southwest Region, the high cost was a known factor at time of final prospectus, and an increase in RATA funding must be based on extraordinary and unforeseeable circumstances.
- The project will replace a poor condition culvert with a fish passable structure, while also improving roadway safety for a half-mile segment of Elochoman Valley Road.
- The county has submitted the request for an additional time extension in a timely manner, in advance of actual project lapsing.
- An additional extension to the construction lapsing date will allow the county to retain its RATA funding while it continues to move the project to construction.

Staff recommends allowing this one-time additional construction lapsing extension of Wahkiakum County's Elochoman Valley Road and Clear Creek Fish Passage RAP project to <u>April 16, 2023</u> per WAC 136-167-040 (5).

Wahkiakum County is requesting an extension to the funding allocated Elochoman Valley Road / Clear Creek project. The reason for the additional extension request is as follows:

This 3-R project is inextricably tied to another project, the Clear Creek drainage project, which is situated in the approximate center of the road project. Since the drainage project will result in construction of a new bridge due to fish passage requirements and other resource agency regulations, it made sense to improve the poor road alignment, to the extent practicable, on either side of the stream crossing in conjunction with the bridge project as previously stated by Pete Ringen, County Engineer at the time.

The two projects were combined into one project in 2017 per request by the funding sources. Sargent Engineers supplied a 90% design Fall / Early Winter of 2019 and the engineers cost of \$2,519,000 for construction which came in \$816,000 over budget. Wahkiakum County had secured funding from CRAB in the amount of \$1,364,000.00 and from RCO / SFR Board in the amount of \$663,407.00.

Wahkiakum County is currently actively pursuing additional funding from RCO to be able to complete the project.

Wahkiakum is intending on using county forces to complete the initial site preparation and removal of overburden material this spring of 2021 and to revise the construction plans with intent to reduce the over-all project cost.

At this time Wahkiakum County Public Works is requesting an additional extension to the funding CRAB has granted for the Elochoman Valley Road / Clear Creek Fish Passage Project.

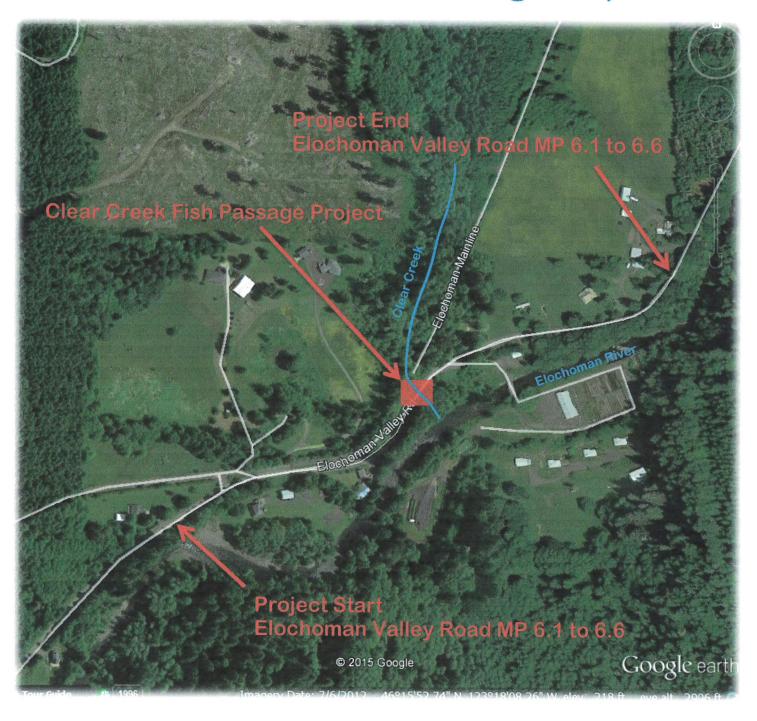

AMENDATORY SECTION (Amending WSR 20-04-076, filed 2/4/20, effective 3/6/20)

WAC 136-500-080 Payback terms. Any loan funded through this program shall have a term not to exceed twenty-four months. The county will be invoiced six months from the date of contract execution and quarterly thereafter until the end of the contract term. If a county desires a longer payback term, the county's legislative authority may request a revised payback term at the next regularly scheduled board meeting.

<u>Simple interest</u> on the amount of the loan shall be the monthly rate of return for the LGIP not to exceed three percent.

If a county pays the county road administration board the principle amount of the loan within six months of the date of contract execution, no interest will be charged and the contract will be closed. Should a county not pay the loan in full within six months of the date of contract execution, interest will be calculated from the date of contract execution to the date of final payment. A county may pay off any loan received through this program before the end of the term to reduce the amount of interest owed.

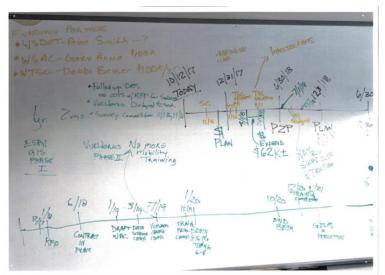

Ongoing Projects Summary



1GIS-Mo's First Planning Meeting October 2017

All major projects are within scope and on budget. Only our Office365 implementation is behind schedule. This is due to lack of resources in systems and security, and compounded by emergent issues with interagency support. We've taken action to address both issues, i.e., additional support at IT System Administration and redefining the scope of interagency support.

GIS-Mo began Go-Live activities January 11 with Kitsap County as the first to submit their 2020 road log. Walla Walla and Okanogan counties have also had their 2020 road log

approved and initial route geometry evaluated for completeness. 31 of 39 counties will provide CRAB with the route geometry, greatly improving the spatial representation of county roads at the State and Federal level.

Disaster recovery is potentially the most significant function of the Information Services Division. In the event of fire, flood, or cyberattack, can CRAB recover its data, and how quickly? We've procured backup services for all data in the Cloud, which includes periodic storage to a device completely disconnected from any networks. This is crucial in the event of certain types of cyberattacks such as "ransomware."

- CRAB Website: Website transfer to WaTech complete and stable
- Office 365: Training and implementation planning scheduled

One accountability audit finding for the road department was regarding procurement, not awarding to the low bidder, not using sealed competitive formal bids, and retainage issues. One management letter for ER&R was regarding rates and contingency. Neither one required CRAB staff to initiate consultation once the situations were explained by the counties.

All the above forms and reports required to be submitted to CRAB by December 31, 2020 in order to maintain compliance with the Standards of Good Practice have been submitted on time by all of the 39 counties, with the exception of one form. Additionally, one county failed to meet the bi-annual surface rating requirements of their surfaced arterials and collectors. That county has committed to a performance improvement plan and we will report on that county's status at the April CRABoard meeting.

Cooperative Procedures for Processing of County Road Accident Reports

All counties are required by WAC 136-28 to have responded to/processed at least 90% of the county road collision reports submitted to them for coding by December 31 of each calendar year. For 2020, 37 of 39 counties were compliant as required with the two remaining counties being very close to compliance and considered to be in reasonable compliance. One issue still plagues the CLAS system, which relates to how the WSDOT program reacts to a "not my jurisdiction" response from the county.

CERTIFICATION

The 1997 State Auditor Office (SAO) audit of CRAB concluded that the minutes of the Board meetings needed specific mention of SAO audits of the counties and of any findings that might relate to the statutory responsibilities of CRAB. The minutes also need to reflect any recommendations from the CRABoard to staff in response to the audits.

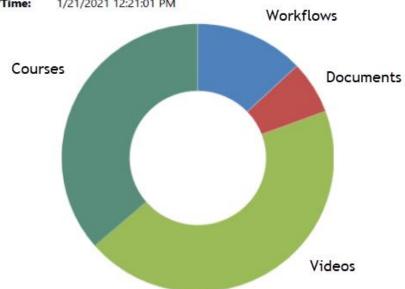

 Design Systems issued a survey in early January to solicit feedback on Pinnacle's content and usability. Staff is currently working with the county user administrators to encourage more response, and will be compiling the results and developing an action plan to address comments and make improvements.

Road Design Conference

CRAB elected to cancel our 2021 Road Design Conference. Based on the
current COVID status and the anticipated vaccine schedule, staff felt that a
conference in March would not be well attended and possibly not allowed at
all under state rules. Campbell's Resort in Chelan has been most gracious to
CRAB in allowing us to cancel the 2020 and 2021 conferences at no cost
despite signed contracts. Their only request was to schedule our next two
conferences for March of 2022 and 2023. We are not alone in our hopes that
COVID will be well under control by March of 2022.

2. UAS Program

• Recent FAA rule changes, announced on December 28, are defined as "advancing safety and innovation" of the drone industry in the United States. The exciting part, and the aspect that garnered the most attention from remote pilots, is the relaxation of rules against night operation and operating above people and moving vehicles. Since 2016, it has been against FAA regulations to operate drones less than 55 pounds (25 kg) at night or over people without a waiver. This rule was seen as stifling innovations in the drone industry, since any useful commercial drone flights would likely need to overfly populated areas and roadways with the possibility of doing so at night. The new rules allow these operations without a waiver for four categories of drones, classified by how much damage they would do if they were to lose control and hit someone. The rules also define the inspection and certification regimes for both aircraft and pilot, as well as stipulating that operators have to have their certificate and ID on their person while flying.

While this seems like great news, there will be a trade off. The rule changes also impose the requirement for "Remote ID", which is said to be "a major step toward full integration of drones into the national airspace system." Certain drones will be required to carry a system that transmits identification messages directly from the aircraft, including such data as serial number, location and speed of the drone, as well as the location of the operator. The rules speculate that this would likely be done over WiFi or Bluetooth, and would need to be receivable with personal wireless devices. The exact technical implementation of these rules is left as an exercise to manufacturers, who have 30 months from the time the rules go into

effect in January to design systems, submit them for certification, and get them built into their aircraft. Drone operators have an additional year to actually start using the Remote ID drones.

For CRAB and the counties, these rule changes mean an immense opportunity to expand our ability to easily collect data remotely.

 As a result of these rule changes, CRAB will be aggressively pursuing upcoming grants from the WSTC to evaluate drone hardware and software in the accurate collection, dissemination and recording of data related to county roads.
